Dear Mr. Bukshtynov:

I am responding to your request made under the *Freedom of Information and Protection of Privacy Act (FIPPA)* for access to an event details report of the David Braley Athletic Centre, located at McMaster University, 1280 Main Street West in Hamilton for the time period from January 1, 2007 to August 1, 2018.

I understand that you spoke with Linda Pestrin of this office and advised her that you required information that strictly pertained to the David Braley Athletic Centre at McMaster University and not other events that may have occurred at McMaster University.

This is to inform you that access has been granted in part to the records. Copies of the requested records are enclosed. Some information contained in the records is protected from release under the *FIPPA*.

It was necessary to sever a portion of the event details report as it contains the nature of injuries of an individual pursuant to the personal privacy provisions in section 21 of *FIPPA*.

Under section 50(1) of *FIPPA*, you may request that the Information and Privacy Commissioner review this decision. Please note that you have 30 days from the receipt of this letter to request a review. Please be aware that there is a \$25.00 appeal fee. The Commissioner's office is located at 2 Bloor Street East, Suite 1400, Toronto Ontario, M4W 1A8, and can be reached by phone at 416-326-3333.
